## "Learning the Hard Way"

(Daniel 4:1-37)

**The Date/Setting:** The time of the events in chapter 4 are not clearly identified, however there are indications that these occurred later in his reign. For instance, at the time of the dream his extensive building program was completed (4:30). History tells us that Nebuchadnezzar died in 562 BC. This means that the latest time of the dream was around 570 BC, allowing seven years for his period of insanity (4:33) and one year of reigning as king in his restored kingdom (4:34-37).

**Nebuchadnezzar's Royal Proclamation:** After the events recorded in this chapter had taken place, the King had a royal proclamation about them circulated. He did so in an effort to teach his people the lesson which God had taught him, the fact that the Most High God has a kingdom that is sovereign over man and will last forever in contrast to man's kingdoms. Based on the fact that the literary style of this chapter resembles the style of Nebuchadnezzar's ancient inscriptions, and the character of the king revealed in this chapter agrees with ancient descriptions of the man, it is concluded that the chapter records the words of Nebuchadnezzar himself.

be lyca to b vict wou <b>Wh</b> mer sucl Meg Cha that	<b>What was God's judgment on Nebuchadnezzar?</b> He imagined himself to be an animal and acted like one. Generally, medical science refers to this as lycanthropy, which is related to a wolf, but more specifically, boanthropy is related to behaving as an ox. Apparently, the disease is curable, and is known to allow its victim sufficient consciousness of self to make intelligent prayer possible. This would explain the king's ability to change his attitude while suffering this madness. <b>What do skeptics say?</b> Skeptics have scoffed at the account Nebuchadnezzar's mental illness in Daniel. They have claimed that it is preposterous to believe that such a thing happened to such a mighty king. However, a Greek writer named Megasthenes, who lived from 312-280 BC related a story told to him by the Chaldeans that sounds similar to Daniel's account. Additionally, it is worth noting that toward the end of Nebuchadnezzar's reign his name disappeared from the historical and governmental records of Babylon and then reappeared for a short time before the King died.
